Section 2: Amount of Gift

A. Initial Gift

In order for a named (endowed) scholarship to be created and sustained, a minimum gift amount of \$10,000 is required. Based on this minimum threshold, annual scholarships of \$500 may be awarded based on an assumed award of 5% of the principal balance. Smaller gifts should be directed to the USD #368 Endowment Unrestricted Fund.

C. Binding Gift

Donor(s) understand and declare that this donation to the USD #368 Endowment Association is absolute and irrevocable and that, after the execution of the Scholarship Agreement, the Donor has no right, title, interest or incidents of ownership in the property given or any additional property contributed to this fund. Donor may request that the scholarship criteria be amended subject to approval by the Endowment Board of Directors. Donor(s) understand that under no circumstances will withdrawals or return of contributions or any investment gains be honored.

Section 3: About Your Gift

A. Expendable or Endowed?

Endowments are permanent funds established to carry out the donor's philanthropic intentions in perpetuity. In essence, endowments are gifts that keep growing and giving. Assets are invested for growth, and the amount available for scholarships each year is based on a "spending rule" that currently distributes 5% of the gift's market value annually.

EXAMPLE: \$10,000 initial donation - annual \$500 scholarship distribution.

In the event we are unable to contact you, we acknowledge that either the principal will be utilized or the scholarship will merge into other funds.

B. Eligibility Criteria

Eligibility criteria are used to determine whether or not a person is qualified to apply for your scholarship. As you consider eligibility criteria, please be flexible; if your eligibility criteria are too narrow, it becomes difficult to award a scholarship each year. As you determine eligibility criteria, you may wish to consider a combination of the following examples for board consideration:

Applicants must attend Paola USD 368
Full-time student (12 hour minimum) at any post-secondary school
Graduate of Paola High School
Enrollment in a specific college
Attend all four years at Paola High School
Participation in a particular sport or extracurricular activity
Attend a post-secondary school in Kansas
Must have a certain GPA, minimum GPA, or GPA range
ACT/SAT composite score
Field of study
Enrollment in a college/university or vocational/technical institute, commercial art school
school of nursing, etc.
Demonstrates leadership
Demonstrates community involvement
Special Talent (music, art, athletic, drama, ag)
